## Type of Application

- New:** New members pay a one-time \$50 initiation fee in addition to the annual membership fee (fee schedule below) and must have their application signed by two current members.
- Renewal:** Current members, including Life Members, must renew their membership every year.

## Membership Type and Annual Fees

- Regular: \$50**
1. Must be at least eighteen (18) years of age.
  2. Must be a United States Citizen.
- Family: \$75**
1. All members of an immediate family, including children under the age of 18 and grandchildren aged 10 or less.
  2. All members must be United States Citizens.
- Junior: \$20**
1. Must submit a completed application requesting Junior Member status signed by a parent or guardian and two (2) current non-family club members with application dues for that current year.
- Life:** Ten times the annual membership fee.
1. Must have been a member for a period of one (1) year.
  2. Must be at least eighteen (18) years of age.
  3. Must be a United States Citizen.
  4. Must submit an application signed by two (2) Lifetime members.
  5. Must submit the application with the applicable fee for Lifetime membership.

**Note:** After July 1, annual dues and fees shall be one-half that of the current year. The initiation fee will remain that assessed for the current year. This reduction of fees does not affect Life Memberships.
